TERMS AND CONDITIONS

Aims and Objectives

The aim of the WGTF of Great Britain and Ireland Limited ("the Company") is to provide by way of certification courses, the skills and knowledge to commence a career in golf coaching and on completing successfully the relevant certification course entry shall be gained by the candidate to membership of the Company, subject to paying a yearly subscription which guarantees continual development and training by the Company.

The course is to be undertaken by either attending on-site training or by way of correspondence.

1. **Application Form**

Candidates must complete and sign an application form to attend the course and return the same no later than four weeks before the start date of the course.

2. **Deposit**

Deposits for courses are non-refundable but can be held over to another future course. The Company may be sympathetic to bona fide cases in which appropriate evidence is provided.

3. **Balance of Payment**

The balance of payment must be paid four weeks prior to the start date of the course. Receipts shall be issued.

4. **Provision of Manual**

The Company shall send the WGTF Training Manual which provides a step by step guide to golf coaching including any other materials such as books and/or tapes on receipt of full payment of the fees whereupon the candidate is deemed to have entered into a training contract with the Company and the candidate's obligations shall be two fold: -

- a) to attend and complete the course.
- b) to become a member of the Company paying a yearly subscription thereby ensuring that in turn he/she receives continual training and development and keeps up-to-date with the latest in golf coaching.

and further where the candidate opts for a correspondence course the candidate is deemed to have entered into a Training Contract on forwarding the application form and on receipt of the Company's training DVD/Video tapes and thenceforth the deposit shall not be refundable.

5. **Venue**

The Company reserves the right to select and if necessary vary the location where the course is to be held and the Company shall provide notice of one week at least of such change of venue to the candidate who shall not have the right to withdraw from the course applied for on the basis of a change of venue and further such change of venue shall not in any way allow for variation the fees.

6. **Disruptive Candidates**

The Company reserves the right to disqualify and remove a candidate from continuing a course if he or she is disruptive or causes damage to any property at the venue where the course is held and such costs incurred in rectifying such damage is to be settled by the candidate concerned. Where the candidates are disruptive the fees are non-refundable.

7. **Intellectual Property**

All course manuals, equipment, videos/DVD's, equipment, course material, logos shall all be deemed to be within the ownership of the Company and any form of reproduction of the same shall not be allowed and shall be seen as a breach of copyright.

8. **Membership Status**

Only candidates endorsed by the Company following satisfactory completion of the course and taking on membership status by paying the yearly subscription can continue to coach claiming association and affiliation with the Company name and can operate under the Company banner. The Company has the right to vary at its absolute discretion at anytime the terms and conditions of its membership services.

Please note that non-payment of the yearly subscription fee disallows the candidate from associating in any way with the Company, which includes not being permitted to:

- a) Put himself/herself forward as a Company coach
- b) Use in anyway the Company's logo on any golf-wear or training
- c) State that the candidate has a certificate from the Company and/or use the certificate obtained from the Company to promote golf coaching in any way.

9. **Company's Prerogative**

The Company has the right to vary at its absolute discretion at anytime the terms and conditions herein.

10. **Force Majeure**

Every effort will be made to carry out the obligations of the Company to provide the course but its due performance is subject to cancellation by the Company and to such variations as the Company may find necessary as a result of any act of God, strike, labour dispute, war, fire, flood, drought, legislation or other cause beyond the Company's control. The

Company shall be under no liability for failures, variations and delays attributable to causes beyond its control.
